Booking Procedures & Rules

Deposits - An initial deposit of \$700.00 is required upon booking your event payable by Visa, MasterCard or Cheque. The TS&M Woodlawn Management must also have a credit card number on file; your booking is not secure unless this occurs.

Gratuities - Are not included in the package. They will be charged at 15% on the final bill

Beverage Service – TS&M Woodlawn provides ample and easily accessible beverage service in our restaurant area. All beverages brought on-site by a booking will be confiscated immediately. All of our sales will be in coordination with the SLGA Laws.

Final Numbers – Any booking must submit final numbers to our Food and Beverage Manager (14) business days before the event. TS&M Woodlawn Golf Club reserves the right to charge for guests not accounted for or no-shows.

Cancellation Policy - Bookings cancelled up to 65 days prior to the event date will be reimbursed the deposit. Cancellations received after that time will not have the deposit returned.

Damage – All damage to the TS&M Woodlawn Golf Club property and or costs occurred from said damage will be the responsibility of the named contact person

Decorations – No tape, tacks, nails or glue is to be used for decorating. All decorations must be removed by 9:00AM the following day

2017 TS&M Woodlawn Golf Club Wedding Agreement & Policies

Contracts, deposits, payments and cancellations

- In order to confirm you event date; TS&M Woodlawn requires the signed contract and a \$700 deposit. No exceptions.
- A valid credit card number is required at time of booking to be listed in the wedding file.
- All deposits are non-refundable and non-transferable.
- All cancellations are required in writing **sixty five (65) days** prior to the events scheduled date.
- Should you cancel within **sixty five (65) days** prior to your event date, the remaining balance of food and beverage will be charged to your credit card on file.
- Any balances not received by due date will be processed on the credit card on file. This includes the final balance following the booking..
- TS&M Woodlawn is not responsible, nor has the capacity to store any items prior to or following your event.
- The room designated for your booking will be available a minimum of one (1) business day prior to your event booking. The restaurant will make every attempt possible to have the room available earlier however will not be responsible for lost or stolen articles.
- TS&M Woodlawn will allow you to park a storage unit for twenty-four (24) hours prior to and twenty-four (24) hours following your event. The storage unit must be pre-approved by TS&M Woodlawn
- TS&M Woodlawn is not responsible for any lost, stolen or damaged items prior to, during or after the course of your event.

Food and Beverage

- TS&M Woodlawn will have first right of refusal to host the banquet in the restaurant. The
 minimum number of guaranteed guests will be what is used for product ordering. Minimum
 numbers cannot be decreased but may be increased up to ten (10) business days in advance of
 the event.
- Due to licensing requirements and quality control issues, all beverages to be served on the premises must be supplied by the TS&M Woodlawn Golf Club.
- Unauthorized beverages are not allowed and strictly enforced.
- The function room will be available for all groups until **one (1) hour** after last call. Last call will be made upon the Food & Beverage Supervisors discretion.
- Selling or serving liquor by the manufacture or registered representative is prohibited.
- Liquor for sampling must be purchased from the restaurant.

Guarantees

- We request a tentative number of guests at time of contract.
- A confirmed menu and all other requirements will be required fourteen (14) business days prior to your booking
- A guaranteed number of meals must be received **ten (10) business days** prior to the event. Guarantees are not subject to a reduction.
- All hosted food and beverage services are subject to a 15% service charge and 5% GST and are not included in menu pricing.
- All prices are subject to change based on market conditions.
